- SERVICES OFFERED—Arts and Crafts, Music, Science and Math Lessons, Creative Drama Experiences, Challenging Games, AM/PM Snacks and Lunch. Visitors are optional services.
- 3. THE SCHOOL'S BUDGET—is figured on a yearly basis and the tuition parent's pay is divided into equal monthly payments. Therefore, no credit will be given for the specified *holidays* listed in the parent brochure and the *two weeks of school vacation*; one week in Winter (December) and one week in Summer (June).
